2024/7/3. CONFIRMATION OF THE MINUTES FROM 13th May 2024

2024/7/6. OXFORDSHIRE COUNTY COUNCIL REPORT:

Residents are urged to continue logging road issues on fixmystreet.

Local matters discussed were the state of the roads. DW has arranged for Matthew Timms, Team Leader, OCC Highway Engagement Team to make a site visit on 17th July to identify areas of concern. Residents are asked to forward areas of concerns (with FMS refs) to Clerk prior to the meeting.

2024/7/4. Public Participation

Caroline Ash raised 3 issues:

- Road around Greys Court suggested that a Slow Down sign be erected. Clerk is looking into the feasibility /costings of this option.
- Offered to hold a summer reception in June 2025 to mark King Charles III official birthday, at her house. More details to follow.
- Asked if there is likely to be a change in planning regulations with the new government.
 ND replied that the RGPC would pass on any changes as/when the Parish Council are informed.

Charlotte Bailey raised parking on Shepherds Green. The ongoing issues were discussed and are covered in Matters Arising.

Fly tipping on Shepherd's Green Lane at entrance to Greys Meadow Studio noted. Clerk to advise SODC for removal.

2024/7/ 5. MATTERS ARISING FROM PREVIOUS MINUTES:

- a) War memorial names. Quote received £3548.40 (inc VAT). ND had a meeting recently with the stone mason and the work to add the missing names will be carried out during the summer/autumn.
- b) 20mph application. Clerk reported that the consultation period had now ended and has moved to the next stage of reviewing the comments/responses.

- c) Golf Course. Clerk has registered RGPCs interest with Rotherfield Peppard PC and will continue to pass information onto residents as and when available.
- d) Risk Assessment. Councillors agreed that Alex Angell (AA) will carry out repairs to damaged/broken benches. AA will send quote for time and replacement bench to Clerk. AA will ensure any plaques are retained/replaced as necessary.
- e) Shepperd's Green parking. Some residents have placed logs on edges, which seems to be working. Still an issue with blocking drives/lanes and NT have asked SODC re: by-laws.
- f) Defib training. Councillors agreed to offer the training using the SCAS Charity service and dates will be arranged and communicated via GAG email list. The cost will be £28 per 4 hour session for hall hire, plus a donation to SCA Charity (amount tbc).
