Thank you!

To everyone who participated in the Great British Spring Clean from 17 March to 1 April. More than 1000 residents participated and together we collected 560 sacks of rubbish from public areas across the two districts. Not only does litter picking make our local area beautiful, there is now growing evidence of the mental and physical health benefits - well done to all who got involved.

Litter

The volume of litter on roadside verges has been, quite understandably, a source of great concern for residents and parish councils alike. South Oxfordshire's waste services, including roadside litter picking, are agreed under a contract with Biffa. The contract, which was signed more than five years ago, commits Biffa to strict targets on bin collections and to keeping our verges tidy with regular litter picks. I have reached out to the leader of the council, the cabinet member responsible and the chief executive, raising the issue of roadside litter and asking for more regular cleans.

The waste team have been working closely with Biffa to make sure they are providing the service our residents pay for and expect.

For the second year in a row, SODC is offering parish "deep cleans". We are also supporting local communities with local litter picks. If your community group would like to borrow equipment for litter picking or request a deep cleanse, please contact waste.team@southandvale.gov.uk to arrange.

Recycling

The government has put on hold plans to overhaul recycling in England and Wales. Under the proposals, aimed at bringing recycling rates up to 65% nationally by 2035, residents across the country would be required to sort their waste into seven (!) separate bins. Nationally, recycling rates have been stagnant at 45% for the past several years. However, South Oxfordshire has the second highest recycling rate nationally – 67%, so we are already exceeding the government's target, some 12 years ahead of schedule.

Contamination is an issue, however. A reminder to residents to please ensure bottles and containers are free of food residue – be sure to wash the Nutella out of the jar before you put it into the recycling. And of course, no plastic film.

Some plastics, including black plastic pots from the garden centre, are not recyclable as they already at the end of their life.

Rigid plastics such as toys, flowerpots (such as the taupe ones that come with gift plants in them) and DVD cases also cannot be recycled. Take the Recycling Quiz to learn more:
