#### SPECIFIC REPORT FOR ROTHERFIELD GREYS

#### HIGHLANDS FARM DEVELOPMENT ROAD STATUS

Subsequent to queries about possible planning breaches, I was asked by the District Councillor to establish whether OCC will be adopting the access road and the roads within the development. OCC officers have confirmed that no application to adopt the roads has been received to date.

The clerk was asked to put an enforcement about the street lighting as not in the planning application. The District Council would be also looking into this.

RO has an early map of plans for Highlands Farm Lane which JOP will check for street lighting plans.

#### THIRD READING BRIDGE

The enthusiasm of Berkshire councils for this project is undimmed and, independent of Oxfordshire councils, they have now commissioned further work to support the 'business case'. I am meeting with OCC officers for a full update next week.

The clerk asked if a second 3<sup>rd</sup> Reading Bridge meeting for local parish councils would be appropriate and was told that when more information is forthcoming, it might be needed.

# DIVERSION OF PUBLIC FOOTPATH NO 1 (PART) THE ROSARY, SHEPHERDS GREEN

I have been asked to comment on the above application and seek the views of the parish council. It was confirmed that the diversion was on the agenda to discuss and the clerk will email the decision to him.

#### **DOG LANE**

I was previously asked to investigate OCC responsibilities in respect of repairing this lane and reported in July that the eastern section from Rotherfield Greys to the Chiltern Way is an unclassified, unmetalled county road with concurrent restricted byway status, and that the western section from the B481 to the Chiltern Way is restricted byway status. A restricted byway is defined as a public right of way on foot, horseback or in a vehicle other than a mechanically propelled vehicle and therefore does not include public use in a motor vehicle. As a restricted byway, Dog Lane is maintainable at the public expense to a level commensurate with its public use; it is therefore not publicly maintained to enable use by motor vehicles as there is no public right to do so. OCC Public Rights of Way officers visited the site and later confirmed that as they have had no complaints in connection with the intended use of Dog Lane, there are no immediate plans to carry out any maintenance. However, I have pointed out that there has been different treatment of Dog Lane in the past, and adjoining Kings Farm Lane (also a restricted byway) recently. As a consequence of this, officers will be undertaking a fresh site visit in the near future to establish and implement a consistent policy.

This is a major bowl of contention as change of use for the road had not been consulted on.

#### **COUNCILLOR PRIORITY FUND**

As previously advised, I have a £15k Councillor Priorities Fund to allocate across my nine parishes. I will divide this in relation to parish size, thus I have £500 available for Rotherfield Greys to match-fund Highways projects. This means if the parish council identifies Highways works costing a total of £1000, I will meet half the cost from my fund. If the works are costed via OCC Highways and undertaken by them, all that is needed is my agreement to proceed; if works are costed and undertaken by third-parties a form will need to be completed followed by a simple OCC approval process. I understand the PC has made some preliminary enquiries and I look forward to receiving a full request.

White lining for village was requested a year and half ago. Cllr David Bartholomew requested the clerk ask again for an update and cc him.

#### 057/18 SOUTH OXFORDSHIRE DISTRICT COUNCIL REPORT:

There was no report from David Nimmo-Smith but the clerk was requested to pursue update on Greys Meadow and The Lamb and when was the CIL meeting with Henley?

#### 058/18 CLERK'S REPORT

The SODC councillor grant for the previous year had been closed as confirmed as spent.

The SODC councillor grant for 2018/19 has been applied for. This will be £500 towards replacing the pad stones on the bus shelter/well housing.

The confirmation of the Knolly's family tree is being sought for correct dates before a history tab is added on the website. Richard Ovey will find out.

The clerk was asked to report a dead cherry tree opposite the Greys Green cricket pitch. JOP noticed it isn't quite dead but who would be the person to report that too? A name was given and the clerk will write to inform of the poor health of the tree.

#### 059/18 PARISH ROADS INCLUDING DOG LANE

ND asked why had two sections of road near the War Memorial junction been repaired? The clerk knew nothing about this and neither did the parish council.

David Bartholomew had received a letter from a parishioner requesting a reduction of speed limit from unrestricted to either 30 or 40 mph in the section coming from Highlands Farm to Rotherfield Greys Village. It has been discussed in previous meeting but there may give an increased risk of planning application for housing developments. The cost would also be an issue. The parish council cannot afford this extra expenditure at the present time.

Dog Lane - A member of the public stated that deliveries and ambulance/fire service cannot access the road due to its poor condition. It was agreed to wait for the report mentioned above and continue to request action to improve the surface. Also his house cannot be sold as viewers found the state of road unacceptable.

#### Correspondence

The OALC via the Woodlands Trust has offered each parish one native tree with plaque to plant to mark the 100<sup>th</sup> Armistice Day event. This is for every parish in South Oxfordshire. This was agreed to apply for. Location is yet to be decided. And permission for a location needed to be sought from the National Trust.

Patricia Dixon requested a GAG for the Grey's Senior Citizens Lunch on the 13<sup>th</sup> November. The Council agreed.

Neighbourhood Policing Newsletter for August was agreed to put on website.

Barclays Bank – Susan Hems is now a signatory for cheques.

Good Neighbour Scheme Support Service – Guidance to set up a scheme. Good Neighbours run the COMET bus service in Nettlebed. This will be kept in mind for COMET buses if/when it is set up.

Chiltern Society – thank you for donation of £150.

PSCO Janice Smith wondered if the parish would like to borrow the SID (Speed Indicator Device) for one/two weeks and get training in using it. As the training was on Wednesday 12<sup>th</sup> it was too late to arrange but the cross parish purchase of a SID will need more training to be arranged.

Consultation on South Oxfordshire CIL Spending Strategy. The clerk had drafted a response:

"The parish of Rotherfield Greys, and the village in particular, has been overlooked in the large development of houses at Highlands Farm. So the example is that a nearby parish is suffering the brunt of a new development but receives no CIL.

The blanket approach of geography over common sense is causing problems with increased traffic through unsuitable rural roads, into a village with no pavements. The parish where the development is adjacent and where the traffic will enter and exit seems to be ignored.

The parish council is asking that when a new large development is happening that a map is looked at. Where is the exit road and where does it exit into? If in a neighbouring parish, surely this is cause to re-consider the CIL and look at mitigation for the increased traffic around that area."

SH asked that she edit the above and is aware of the deadline of 16<sup>th</sup> September 2018. This was agreed.

"The OCC has received a request to divert footpath 330/20. It would change the beginning of the footpath (staring next to the Rosary). Instead it would carry on down the road and then turn into field (south) to join up again. This would allow the Rosary to increase the size of their garden widthways and create privacy for the house. It would increase the length of the path by 23 metres."

The diversion was agreed and the clerk would inform the Rights of Way Officer.
