#### 003/19 RESOLUTION TO ADOPT MINUTES OF PREVIOUS MEETING (19/11/2018):

The minutes contained an addition and the following paragraph was added:

"The planning application P18/S3552/FUL) Broadplat House for Change of Use of verge, was discussed at the end of the meeting and all councillors present agreed to OBJECT with comments: Highway authority confirms that the verge is not required for road widening. Any services under the land, serving surrounding properties, are reserved to existing users. Confirmation that ownership of the land is not claimed by any surrounding neighbours."

Signing was discussed as Dog Lane was now being used more and for various unsavoury purposes where the police had to be called. New signs with wording 'restricted byway' would be suggested.

### DIVERSION OF PUBLIC FOOTPATH NO 1 (PART) THE ROSARY, SHEPHERDS GREEN.

I have been invited to comment on this application and seek the views of the PC.

Although the reason for the new amendment to the diversion was questioned, the reason did not seem to justify another amendment. The Campaign to Protect Rural England had requested this and stated it allowed existing paths to join up. Although it was evident the footpath had been diverted many years ago and would have been needed to be aligned correctly (through The Rosary's garden), the new route was not seen as an issue.

#### P18/S3552/FUL - 'BROADPLAT HOUSE', BROADPLAT

I am advised that this planning application has been withdrawn.

#### LINE MARKING WORKS (DRAGON'S TEETH AND ROUNDELS)

I have confirmed to the officer that I would contribute £500 towards this from my Councillor Priority Fund.

David Bartholomew was thanked for this.

It was confirmed that the above line marking had been done but the refresh of the thick white lines to the edges of the road had not. John Hill mentioned that the moving back for the 'chevron' sign at Broadplat junction which is seen as impending sightlines, as not been done.

#### **CAVERSHAM QUARRY**

The internal road for backfill leading from the A4155 to the weighbridge has been constructed, as has the weighbridge itself. Construction of the junction on the A4155 to the internal road has stalled due to disagreements over specification between OCC and Tarmac. It is now likely backfilling will not commence until February. It is anticipated backfilling will involve approximately 50 HGVs per day visiting the site. It is likely half will come through Henley/B481 and half through Reading. Test drilling for a potential new site adjacent to Shiplake College is currently taking place (this is in response to the OCC call for potential future sites some ten years ahead)

Questions were asked about the backfill and it will be inert as in a floodplain.

Backfill trucks delivering to the Dog Golf Course, Church Lane was asked about – David Bartholomew passed this question over to the District Councillor David Nimmo-Smith.

#### THIRD READING BRIDGE

As previously reported, the enthusiasm of Berkshire councils for this project is undimmed. I attended the Reading Area Transport Forum on 27th November and the bridge was an agenda item. I can confirm that independent of Oxfordshire councils, Berkshire has now commissioned further work to support the 'business case'. The work is being conducted on a pro bono basis by consultants hoping to move the project forward. Reading asked SODC to 'safeguard' the proposed site of the bridge in the SODC local plan, but this has been refused on the basis of lack of detail and certainty the project will proceed. OCC supports the refusal.

#### TOWN AND PARISH LIAISON EVENT THURSDAY 17TH JANUARY 2019

As part of the Thriving Communities vision, OCC wants to move away from the traditional top-down service design and delivery and talk to people to help shape plans and hear local voices. To support this, there will be a town and parish liaison event on Thursday 17th January 2019 at Sonning Common Village Hall starting at 2pm and ending at 5pm. The event will start with a short presentation followed by round table discussions. I am concerned to note that nobody from RG PC has registered to attend the event. Susan Hems confirmed she would register for this event.

#### 005/19 SOUTH OXFORDSHIRE DISTRICT COUNCIL REPORT:

David Nimmo-Smith confirmed that the Third Reading Bridge was not in the Local Plan for safe guarding the land on the South Oxfordshire side, as mentioned above.

The **SODC Local Plan** is signed off with proposals and now in consultation from 7<sup>th</sup> January – mid February. There will be a public exhibition with officers to take questions at Henley Town Hall Saturday 19<sup>th</sup> 10-2pm and it was encouraged that people see the proposals. The plan will be then reviewed with any feedback and the intention is that the plan will be adopted by the end of year.

Greys Meadow application to remove condition 7 (driveway) will be going to planning committee on Wednesday 16<sup>th</sup>. David Nimmo-Smith kindly offered to pass the parish council response to the committee, if the responses emailed to him soon. He was thanked for this.

SODC are going through their Budget cycle and would be put forward for a likely increase of £5 per band D house roughly 4%.

#### 006/19 CLERK'S REPORT

The clerk attended the Neighbour Planning meeting on  $3^{rd}$  December at Henley Town Hall. The next NP meeting is on the  $21^{st}$  January where the subject of a request for a CIL payment for pavements (£65,000) in the village will be discussed as an agenda item. Since my last report of November 2018 I have walked public rights of way in Lambridge Wood. Light clearance work has been carried out by the Path Maintenance Volunteers and many of the arrows on the trees have been refreshed. The paths are drier than normal for the time of year because of the prolonged dry spell.

Nearby Footpath 27 at Grange Farm has been improved. The representative of the new landowner has met with the Area Secretary of the Chiltern Society Rights of Way Group and has clearly marked the line of the footpath through arable land. Unfortunately the damaged green metal finger post at the road end has still not been replaced by the OCC team.

#### 012/19 BUDGET 2019/20 AND PRECEPT

The budget was discussed and agreed and the Precept request form was signed. The Precept for 2019/20 was decided on at £8,014 down from 2018/19 precept of £8,060. This was recommended by the SODC.

It was decided to maintain 2018/19 S137 charity donations so the Royal British Legion £100 and £50 to the phone restoration committee was continued. This was agreed. This is still within the limit of £2,020. Total S137 payments (including subscriptions) suggested at £2,011.89. A full list was read out and attached to the minutes and on the website.

Suggestions and a quote was requested from OCC Highways for Rocky Lane junction which has a dangerous sharp bend and a camber and a problem with draining water. As this was not yet received a figure of £3,000 was set aside.

The budget 2019/20 was agreed.

#### 013/19 Matters arising for information only

The **USB** stick for a backup of the parish council documents was unable to be done as the USB had failed on the clerk's end. A new USB will be purchased and updated and then swapped with Nick Digby.

The clerk informed the council that it was an election year and posters 'Publication of Notice of Election & Nominations Open' will be out on GAG and noticeboard by 26<sup>th</sup> March. There were some amendments to be made to the Registration of Interests' for two councillors but all councillors will have to complete them again anyway by 4<sup>th</sup> June.
